Privacy statement

Rederij Groen BV, Dr. Lelykade 156, 2583 CN The Hague ensures at all times the privacy rights of the person whose personal data is processed. Rederij Groen B.V. deals confidentially with collected personal data and in all cases adheres to the requirements set by the current privacy legislation.

Personal data

Rederij Groen B.V. collects only personal data that have been made available to it explicitly and voluntarily. The information may include first and last name, address details, gender, telephone number, e-mail address, etc. The categories of processing are: personnel / payroll administration, crew administration, customer relationship management (sales, sales administration).

Rederij Groen B.V. may process personal data if required to do so by law or by contract.

Rederij Groen B.V. may process personal data based on a vital interest, public interest or legitimate interest. Rederij Groen B.V. informs the person concerned about this.

If the personal data are not obtained directly from the person concerned, Rederij Groen B.V. will inform the person concerned about the source from which the personal data originated.

Purposes

Rederij Groen B.V. will only use the personal data for the purpose for which they were provided. Rederij Groen B.V. processes personal data, including payroll administration, crew administration, relationship management.

Storage period

Rederij Groen B.V. shall not store the personal data provided for longer than is necessary for the purposes for which they were collected.

Rights involved

The person whose personal data are processed has - subject to legal exceptions - the right to request Rederij Groen B.V. to request access to and / or rectification and / or erasure of the personal data and / or restriction of the relevant processing.

The person concerned also has the right to object to the processing and Rederij Groen B.V. transfer the data of the data subject - at his or her request. Rederij Groen B.V. shall comply with each of the aforementioned requests within one month, unless this can for example not be demanded by it within the aforementioned period due to complexity.



If the processing of personal data is based on the consent of the data subject, then the data subject has the right to withdraw the permission at any time.

The person concerned has the right to file a complaint with the relevant supervisory body, namely the Netherlands Authority for the Protection of Personal Data.

Information not obtained from the person concerned (if applicable, also specify) If the information is not obtained from the person concerned, Rederij Groen B.V. informs the person concerned about the source from which the personal data originates and, if applicable, whether they originate from public sources.

Exchanging data with others

Rederij Groen B.V. never provide personal data to third parties, unless this is necessary for the execution of an agreement, is obliged to do so by virtue of the law, if it has a legitimate or general interest to do so, or if it has received explicit permission for this. Recipients and processors with which Rederij Groen B.V. exchange of personal data can be found in Rederij Groen B.V. record processing register.

Profiling and cookies

Rederij Groen B.V. uses cookies. A cookie is a simple small file that is sent along with pages from this website and stored by your browser on the hard disk of your computer. Rederij Groen B.V. uses cookies to remember settings and preferences of the users, so that, among other things, it is possible to keep track of which pages are visited and thus to build up a profile of the online behavior. The cookies can be turned off via the browser.

Rederij Groen B.V. uses Google Analytics. This program provides important statistics on the number of visitors, the pages visited and other essential information with which Rederij Groen B.V. the website can constantly improve for its visitors. These statistics are anonymous and can not be traced back to a specific person or user.

Exchanging data to a third country or international organization

Rederij Groen B.V. notify the data subject if it exchanges personal data with a third country and / or international organization. In any case, it provides information about the level of protection of the country concerned (adequacy decision or other appropriate guarantees) and how a copy can be obtained.
